ANTI-RAGGING RULES AND REGULATIONS

Date: 12/05/22

(In Accordance with UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009)

1. Definition of Ragging

Ragging is any act that causes physical or mental harm, fear, or embarrassment to a student, especially by seniors. It includes actions like teasing, abusing, threatening, forcing someone to do things against their will, or creating an environment of fear or discomfort. Ragging can be verbal, physical, or psychological, and is strictly prohibited under Indian law and college regulations.

2. Legal Framework

Ragging is a **criminal offence** under:

- UGC Regulations 2009
- Indian Penal Code (IPC) Sections 294, 323, 506, and 509.
- Patna University Ordinance (if applicable).

Punishable acts include:

- Imprisonment up to 3 years.
- Fine up to ₹25,000.
- Expulsion, suspension, or cancellation of admission.

3. Prohibited Conduct

Any act of ragging is strictly **prohibited** within:

- College premises (classrooms, canteens, corridors, libraries, hostels).
- Transportation organized by the college.
- Off-campus events or activities associated with the institution.

4. Disciplinary Action for Ragging

Depending on the severity of the act, the college may take the following actions:

- Written warning
- Suspension from classes
- Withholding scholarships or exam results
- Debarring from campus placements
- Rustication or expulsion
- Filing of FIR with local police authorities
